€8,000,000,000 Euro Medium Term Note Programme

This supplement dated April 04th , 2013 (the "Second Supplement") is supplemental to, and must be read in conjunction with, the base prospectus dated December 04th, 2012 prepared in relation to the €8,000,000,000 Euro Medium Term Note Programme (the "Programme") of Groupe Auchan S.A. and Banque Accord S.A. (hereinafter referred to as "Groupe Auchan" and "Banque Accord", respectively, or together as the "Issuers") and the first supplement dated February 04th, 2013, which were approved by the *Commission de Surveillance du Secteur Financier* (the "CSSF") on December 04th, 2012 and on February 04th, 2013, respectively, (together, the "Base Prospectus") as a base prospectus for the purposes of Article 5.4 of Directive 2003/71/EC as amended (the "Prospectus Directive") and Article 8.4 of the Luxembourg Law on prospectuses for securities dated July 10th, 2005 as amended (the "Luxembourg Law").
