This second supplement dated January 24, 2018 (the "Second Supplement") is supplemental to, and must be read in conjunction with the base prospectus dated June 2nd, 2017, prepared in relation to the €8,600,000,000 Euro Medium Term Note Programme (the "Programme") of Auchan Holding and Oney Bank (hereinafter referred to as "Auchan Holding" and "Oney Bank", respectively, or together as the "Issuers"), which was approved by the *Commission de Surveillance du Secteur Financier* (the "CSSF") on June 2nd, 2017 and the first supplement dated November 20th, 2017 (together, the "Base Prospectus") as a base prospectus for the purposes of the Directive 2003/71/EC as amended by the Directive 2010/73/EU (the "Prospectus Directive") and Article 8.4 of the Luxembourg Law on prospectuses for securities dated July 10th, 2005 as amended (the "Luxembourg Law").

This Second Supplement constitutes a supplement to the Base Prospectus for the purposes of article 16 of the Prospectus Directive and article 13 of the Luxembourg Law in order to:

- I) Reflect the recent events particular to Auchan Holding, the modification of the Supervisory Board members and the Management Board members of Auchan Holding and update the outside activities of the management of Auchan Holding.
- II) Reflect the appointment of a new member of the Board of Directors of Oney Bank and update the outside activities of the management of Oney Bank.
- III) Incorporate certain legends and selling restrictions relating to Regulation (EU) No 1286/2014 (the PRIIPs (packaged retail and insurance-based investment products) Regulation), MIFID II Product Governance and Regulation (EU) N°2016/1011 (the "Benchmark Regulation").

The Issuers accept responsibility for the information contained in this Second Supplement. The Issuers declare that, having taken all reasonable care to ensure that such is the case, the information contained in this Second Supplement is, to the best of their knowledge, in accordance with the facts and does not omit anything likely to affect the import of such information.

Save as disclosed in this Second Supplement and in the first supplement dated November 20th, 2017 (the "**First Supplement**"), there has been no other significant new factor, material mistake or inaccuracy relating to the information included in the Base Prospectus since the publication of the Base Prospectus. To the extent that there is any inconsistency between (a) any statements in this Second

Supplement or any statement incorporated by reference into the Base Prospectus by this Second Supplement and (b) any other statement in, or incorporated by reference into, the Base Prospectus, the statements in (a) above will prevail.

Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meaning when used in this Second Supplement. COVER PAGE

The following paragraph shall be added at the bottom of the cover page of the Base Prospectus:

Amounts payable under the Notes may be calculated by reference to EURIBOR, LIBOR, TEC10, EONIA, CMS, Consumer Price Index or Harmonised Index of Consumer Prices which are respectively provided by the European Money Markets Institute ("EMMI"), ICE Benchmark Administration Limited ("ICE"), Agence France Trésor ("AFT"), European Banking Federation ("EBF"), International Swaps and Derivatives Association ("ISDA"), Institut National de la Statistique et des Etudes Economiques ("INSEE") and Eurostat ("Eurostat"). According to Article 29(2) of the Benchmark Regulation (Regulation (EU) 2016/1011) (the "Benchmark Regulation"), a credit institution (such as Oney Bank) is required to state in the Base Prospectus whether, for securities issued on its basis referencing a benchmark, the administrator of the respective benchmark is registered on the register prescribed by the Benchmark Regulation. As at the date of this Base Prospectus, the EMMI, ICE, AFT, EBF, ISDA, INSEE and Eurostat do not appear on the register of administrators and benchmarks established and maintained by the European Securities and Markets Authority pursuant to Article 36 of the Benchmark Regulation. As far as the Issuers are aware, the transitional provisions in Article 51 of the Benchmark Regulation apply, such that EMMI, ICE, AFT, EBF, ISDA, INSEE and Eurostat are not currently required to obtain authorisation or registration (or, if located outside the European Union, recognition, endorsement or equivalence)."

NOTICES

The following paragraph shall be added on page 2 of the Base Prospectus before the paragraph starting by "This Base Prospectus is to be read in conjunction with (...)":

"MIFID II PRODUCT GOVERNANCE / TARGET MARKET – The Final Terms in respect of any Notes may include a legend entitled "MiFID II Product Governance" which will outline the target market assessment in respect of the Notes and which channels for distribution of the Notes are appropriate. Any person subsequently offering, selling or recommending the Notes (a "distributor") should take into consideration the target market assessment; however, a distributor subject to Directive 2014/65/EU (as amended, "MiFID II") is responsible for undertaking its own target market assessment in respect of the Notes (by either adopting or refining the target market assessment) and determining appropriate distribution channels.

A determination will be made in relation to each issue about whether, for the purpose of the MiFID Product Governance rules under EU Delegated Directive 2017/593 (the "MiFID Product Governance Rules"), any Dealer subscribing for any Notes is a manufacturer in respect of such Notes, but otherwise neither the Arranger nor the Dealers nor any of their respective affiliates will be a manufacturer for the purpose of the MIFID Product Governance Rules.

PRIIPS REGULATION - PROHIBITION OF SALES TO EEA RETAIL INVESTORS - The Notes are not intended to be offered, sold or otherwise made available to and should not be offered, sold or otherwise made available to any retail investor in the European Economic Area ("EEA"). For these purposes, a retail investor means a person who is one (or more) of: (i) a retail client as defined in point (11) of Article 4(1) of MiFID II; or (ii) a customer within the meaning of Directive 2002/92/EC (as amended, the "IMD"), where that customer would not qualify as a professional client as defined in point (10) of Article 4(1) of MiFID II. Consequently no key information document required by Regulation (EU) No 1286/2014 (as amended, the "PRIIPS Regulation") for offering or selling the Notes or otherwise making them available to retail investors in the EEA has been prepared and therefore offering or selling the Notes or otherwise making them available to any retail investor in the EEA may be unlawful under the PRIIPS Regulation."

- (ii) a customer within the meaning of Directive 2002/92/EC (as amended, the "Insurance Mediation Directive"), where that customer would not qualify as a professional client as defined in point (10) of Article 4(1) of MiFID II."

FORM OF FINAL TERMS

The following legend will be inserted at the top of page 106 of the Base Prospectus:

"[MIFID II product governance / Professional investors and ECPs only target market – Solely for the purposes of [the/each] manufacturer's product approval process, the target market assessment in respect of the Notes has led to the conclusion that: (i) the target market for the Notes is eligible counterparties and professional clients only, each as defined in Directive 2014/65/EU (as amended, "MiFID II"); and (ii) all channels for distribution of the Notes to eligible counterparties and professional clients are appropriate. Any person subsequently offering, selling or recommending the Notes (a "distributor") should take into consideration the manufacturer['s/s'] target market assessment; however, a distributor subject to MiFID II is responsible for undertaking its own target market assessment in respect of the Notes (by either adopting or refining the manufacturer['s/s'] target market assessment) and determining appropriate distribution channels].

[PRIIPS REGULATION - PROHIBITION OF SALES TO EEA RETAIL INVESTORS - The Notes are not intended to be offered, sold or otherwise made available to and should not be offered, sold or otherwise made available to any retail investor in the European Economic Area ("EEA"). Consequently no key information document required by Regulation (EU) No 1286/2014 (as amended, the "PRIIPS Regulation") for offering or selling the Notes or otherwise making them available to retail investors in the EEA has been prepared and therefore offering or selling the Notes or otherwise making them available to any retail investor in the EEA may be unlawful under the PRIIPS Regulation]."
